Any act of physical or mental abuse on the ground of color, Caste, Gender, Race, Religion, Language, Economic background or any Other Discriminative behavior.

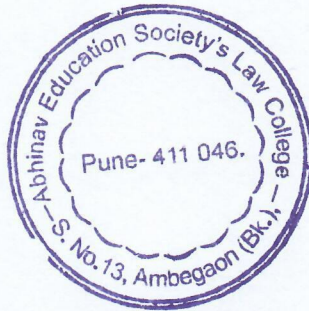
