The National Legal Services Authority adopted the National Legal Services Authority (Legal Aid Clinics) Scheme, 2010 for establishing Legal Aid Clinics throughout the country. The scheme authorizes the State Legal Services Authority to grant permissions for establishing the Legal Aid Clinics in their respective State. The Legal Aid Clinic of **ABHINAV LAW COLLEGE** is recognized by the Maharashtra Legal Services Authority and established in and working since the academic year 2018-2019.

The Legal Aid and Legal Literacy Cell serve the two-fold purposes - first to provide free legal advice and other services to economically weaker people and second, they direct the energies of the students of law in contributing to the society.
