- 8. To facilitate SC/ST students to avail of the Scholarships offered by the Government.
- 9. To conduct remedial coaching classes for the students (priority to SC/ST) for their academic improvement.

10. To constitute the "Caste Based Discrimination Monitoring Committee" to execute the functions and achieve the objectives of the SC/ST Cell.
